**COPYRIGHT ASSIGNMENT INSTRUCTIONS**

Under provisions of the Copyright Revision Act of 1976, JOEH Inc. must obtain a copyright transfer for each accepted article. The principal author, and any and all co-authors, should read the information on the form, sign where indicated, and send the signed form with your submission. No manuscript will be published without a completed copyright transfer form; no exceptions will be made due to an author's temporary absence from his usual location or permanent change of location.

If an author is deceased, the copyright transfer form must be executed by the legal representative (executor, administrator) of the estate and a copy of the death certificate enclosed.

If a submission is rejected, the copyright transfer will be voided.

**Independent Authors and Work Done for Hire**

Manuscripts prepared in connection with work performed by employees at the request of a private employer can be considered "work done for hire." In this case, ownership of copyright remains with the employer. In such instances, the copyright transfer letter must also bear the typed name, title, and dated signature of an authorized representative of the employer. In addition, the notation "Work Done for Hire" should follow the title of the manuscript.

Following the article title and name and affiliation of the principal author, independent authors and work done for hire should submit the following copyright transfer (Form A below). The statement must be signed by all authors above their typed names and must include the date of signature.

**Government-Connected Authors**

Work performed by a federal employee, government grant recipient, or government contractor employee cannot be copyrighted. This type of work must be accompanied by a copyright status affidavit as a substitute for the regular copyright transfer. As with the copyright transfer, all authors must sign and date the form.

Government-connected authors, please use the following affidavit (Form B below). This affidavit must also be signed by all authors above their typed names and must include the date of signature.
